# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.missmolliesbrownies.com and Miss Mollie's Brownies, Inc. and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, Miss Mollie's Brownies may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Miss Mollie's Brownies's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

# **Use of your Personal Information**

# **Sharing Information with Third Parties**
